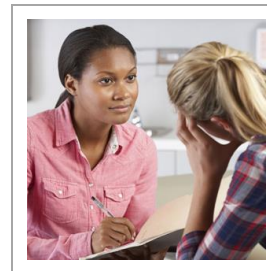
Program Descriptions

Evangelism Through Advocacy



Christian-based groups, organizations and ministries are trained in victim services to begin implementing standardized practices when serving the community and offering ministry. Get started distinguishing your organization today! Apply or submit an RFP!

Victim to Advocacy Program



Do you manage victims/survivors of sexual assault, human trafficking & intimate partnership violence who are currently enrolled in a treatment program? Survivors use their experience, the knowledge gained in recovery to passionately pursue a career in victim services. Apply on behalf of your group or organization to receive a specialized training rate?

Inmate to Advocate Program



Eager to initiate Restorative Justice programs at your correctional facility? Inmates learn how their crime impacted their victims, and simultaneously receiving a professional certification. Complete an RFP!

Program Requirements

Program members have special benefits that are not offered to individual course participants. To be eligible for the program you are interested in, you must be a member of a group who is authorized to publicly use your group's name. Each program has additional requirements found in the program's brochure.

Groups approved into programs get great rates and customized sessions!

For Large Groups & Organizations

To submit an RFP, the group of participants seeking training must be more than 40 on an annual basis. RFPs are also accepted by organizations who seek a one time training that hosts more than 40 participants, but does not desire annual based training.

*The inquiring member must have decision-making authority within the organization or be willing to present approval from a decision-maker.

*The inquiring party must be a manager, senior or executive level leader within the organization.

Other Groups

You do not need to be an organization to enter a program structure. If you have a group larger than 10, but less than 40, you may apply for group rates using our application form. You will receive similar benefits as RFP submissions, if your application is approved.

Associate Case Manager Training Program



Participant Target

- Office staff and intake specialists of crisis intervention programs
- Caregivers in health facilities/out-patient staff and
- Other professionals who are underqualified to perform needs assessment and service planning with victims/clients but offer indirect services to victims/clients.

Case Management Training Program



Participant Target

Community colleges with these degree programs:

- *Psychology
- *Criminal Justice
- *Sociology

Provides participants (eligible associate degree level graduates within those programs) to enter our program for the purpose of connecting a career within their field of study.

Case management staff in need of professional development in service areas such as court escorting, providing needs assessments, and managing case plans.

Course participants learn how to:

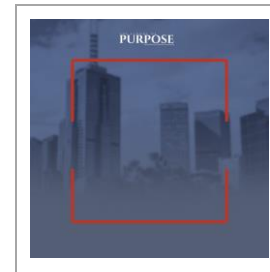
- *Provide court liaison services to victims as they cooperate with law enforcement and the District Attorney to prosecute their offenders.
- *Use victim scenarios to identify needs common to victimization types and which solutions are commonly used to address them across various program scopes.
- *Consider the trauma of domestic violence, human trafficking and sexual assault victims/survivors when interviewing and performing needs assessments.

For community programs who serve victims and residents who have experienced recent crisis, they are empowered to learn aspects of housing plans, professional development plans, and much more! Their clients, members and participants will enhance the quality of work performed.

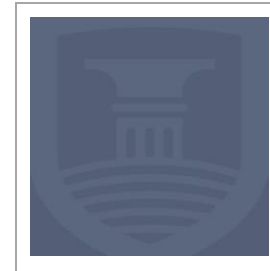
Our course is unique in that it focuses primarily on teaching victim services through community program structures.
